




# A Complete Ecbolic & Uterine Cleansing Tonic

Retention of fetal membranes, or retained placenta, usually is defined as failure to expel fetal membranes within 24 hrs after parturition. Normally, expulsion occurs within 3-8 hr after calf delivery. The incidence in healthy dairy cows is 5% - 15%, whereas the incidence in beef cows is lower. Retained placenta is most commonly associated with dystocia, milk fever (metabolic diseases) and twin births. Cows with retained fetal membranes are at increased risk of developing metritis, ketosis, mastitis, and even abortion in a subsequent pregnancy.


#### **Recommended Usage:**

- In case of retained placenta, administer double dose (100 ml for large animals) twice on first day followed by single dose twice daily for 3-5 days or as directed by the veterinarian.
