



A Coherent Approach to Prevent & Control Mastitis

Bovine mastitis is the persistent, inflammatory reaction of the udder tissue due to physical trauma or microorganisms infections. It is a primary endemic disease of dairy cattle, and milk-secreting tissues and ducts of the udder may be damaged or sometimes permanent damage can occur. The disease is recognized by physical, chemical, and bacteriological changes in the milk and pathological changes in the glandular tissue.


